Warranty and End User License Agreement

Limited Warranty

HARDWARE: TechSphere Co. (“Techsphere”) warrants to the original end user (“Customer”) that this product will be free from defects in workmanship and materials, under normal use, for one year from the date of original purchase from TechSphere or its authorized resellers. TechSphere’s sole obligation under this express warranty shall be, at TechSphere’s option and expense, to replace the product or part with a comparable product or part, repair the product or part, or if neither repair nor replacement is reasonably available, TechSphere may, in its sole discretion, refund to Customer the purchase price paid for the product or part. Replacement products or parts may be new or reconditioned. TechSphere warrants any replaced or repaired product or part, and any hardware upgrade to which Customer is entitled under an agreement between Customer and TechSphere, for a period of ninety (90) days from shipment, or through the end of the original warranty, whichever is longer. All products or parts that are replaced become the property of TechSphere. *VP-II™ NCU, VP-II™ Hub, VP-II™ Data Repeater, and VP-II™ Converter* are also covered under this Limited Warranty.

SOFTWARE: TechSphere warrants to Customer that the *VP-IIX™ NetControl, VP-II X™ NetControl Lite, or VP-IIX™ NetControl Freeware* licensed from it will perform in substantial conformance to their program specifications, for a period of ninety (90) days from the date of original purchase from TechSphere or its authorized reseller. TechSphere warrants the media containing software against failure during the warranty period. No updates are provided. TechSphere does not provide warranty for any third-party applications software that is licensed to Customer by the third party. TechSphere’s sole obligation with respect to this express warranty shall be (at TechSphere’s discretion) to refund the purchase price paid by Customer for any defective software product, or to replace any defective media with software which substantially conforms to applicable TechSphere’s published specifications. TechSphere makes no warranty or representation that its software products will meet Customer’s requirements or will work in combination with any hardware or applications software products provided by third parties, that the operation of the software products will be uninterrupted or error free, or that all defects in the software products will be corrected.

OBTAINING WARRANTY SERVICE: Customer must contact a TechSphere Technical Support, Customer Service center, or its authorized reseller which Customer purchased product(s) from within the applicable warranty period to obtain warranty service authorization. Dated proof of original purchase from TechSphere or its authorized reseller will be required. TechSphere is not responsible for Customer products or parts received without a warranty service authorization. TechSphere may ship a replacement product or part prior to receiving the original product or part (“advance exchange”). If advance exchange is not available, then the repaired product or part will be shipped as soon as reasonably possible, which will be no later than thirty (30) days after TechSphere receives the original product or part. The repair and replacement process for products or parts in locations outside the United States will vary depending on Customer’s location.

Products or parts shipped by Customer to TechSphere must be sent prepaid and packaged appropriately for safe shipment, and it is recommended that they be insured or sent by a method that provides for tracking of the package. When an advance exchange is provided and Customer fails to return the original product or part to TechSphere within thirty (30) days from the date the warranty service authorization is issued, TechSphere will charge Customer the then-current published catalogue price of such product or part.
